LIBOR BYLAWS ARTICLE XI

SECTION 4. BOARD OF DIRECTORS

The governing body of LIBOR shall be a Board of Directors all of whom must be REALTOR® members of LIBOR. The Board shall be composed of the following:

- a) Twenty-seven (27) At-Large Directors
- b) The Executive Committee of LIBOR.

SECTION 6. ELIGIBILITY

e) No more than four (4) At-large Directors may be from the same firm at the time of election or appointment to fill a vacancy.

f) No more than thirteen (13) At-large Directors may be from any one particular County at the time of election or appointment to fill a vacancy.
